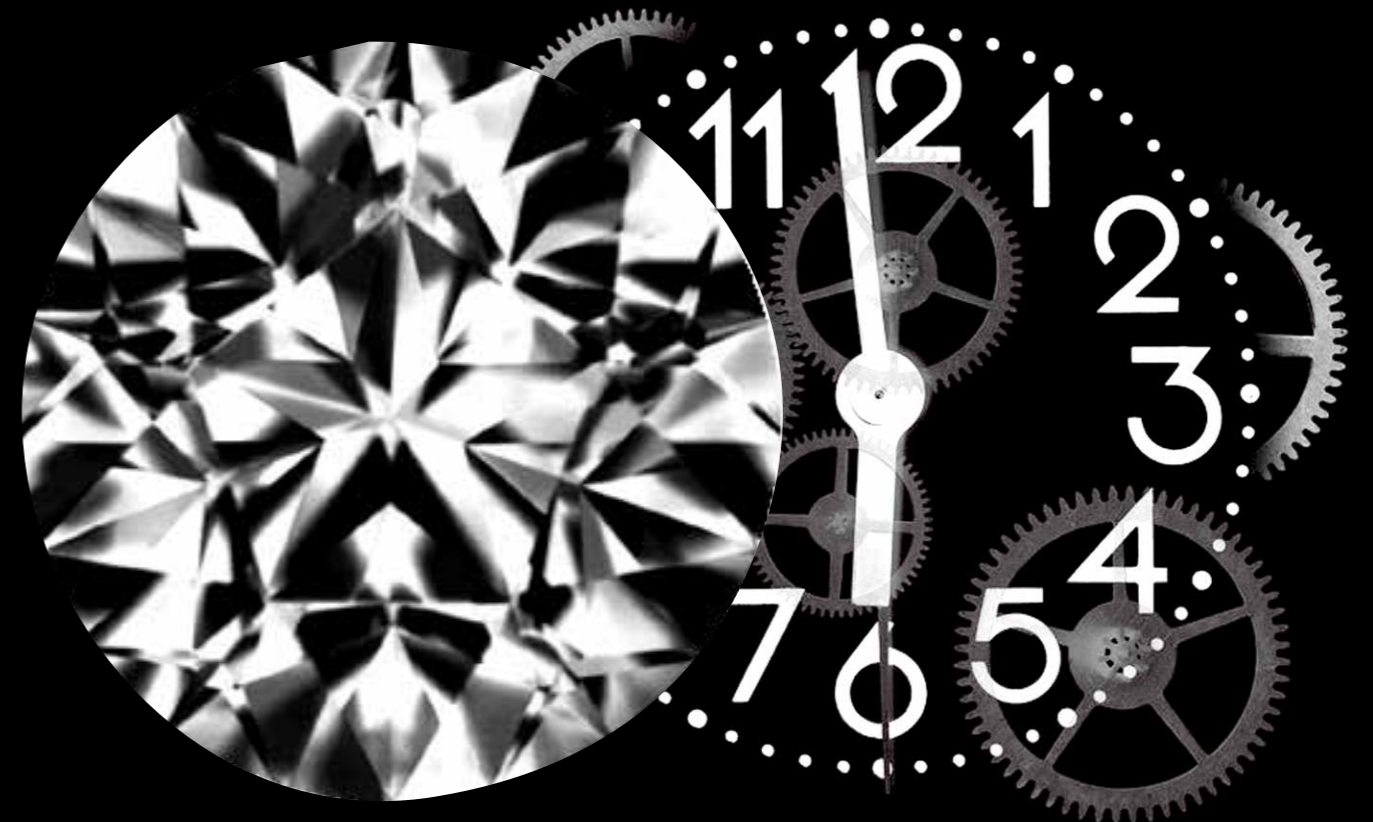

03. 04.
